Economically, corruption equates to less than optimum allocation of resources and inequitable distribution of that lesser total production. We are all poorer for corruption.

St Johns College [SJC] is the Anglican College on the St Lucia Campus [SLC] of The University of Queensland [UQ]. It is a partnership between the Brisbane Diocese of the Anglican Church of Australia [BDAC]. The Warden of SJC is Rev. Canon Prof. Dr John Morgan [Morgan]. Morgan has decided to increase the money generated by SJC by defrauding students [male and female] by

convincing them they are accepted as residents of SJC on SLC of UQ, with the increased security and safety [a major concern for their parents] of having the campus patrolled and under CCTV by a professional security division of UQ. They pay their accommodation charge in advance, then a dozen students, male and female, discover that Morgan has had the BDAC acquire two asbestos ridden derelict hovels off campus, and they are to reside in there. With the accommodation charge of \$300 pw, Morgan SJC and BDAC are making a "rental return" on their investment of \$1,800pw. Of course, the hovels were just three bedroom houses, but Morgan had his "maintenance" men "modify the building.
